I, Arani Guha, Partner of M/s. K Arun & Co., Practicing Company Secretaries, appointed by the Board of Directors of **DLX LIMITED** (the Company) to act as the Scrutinizer for the purpose of scrutinizing the voting process through Remote E-voting and Ballot Papers conducted pursuant to the provisions of Sections 108 and 109 of the Companies Act, 2013 ("Act") read with Companies (Management and Administration) Rules, 2014 and Regulation 44(1) of the **Securities And Exchange Board Of India (Listing Obligations And Disclosure Requirements) Regulations, 2015**, in respect of the Resolutions mentioned in the Extra Ordinary General Meeting (EOGM) Notice dated 15<sup>th</sup> February, 2016.

A person whose name was recorded in the Register of Members or in the Register of Beneficial Owners maintained by the Depositories as on the cut-off date i.e. 14<sup>th</sup> March, 2016 was entitled to vote on the resolutions of the EOGM Notice.

The Company had engaged the services of its Registrar & Transfer Agent, Central Depository Services India Limited (CDSL) for providing remote e-voting facility and the service provider had set up the remote e-voting facility on its website https://www.evoting.cdsl.com/.



The Service Provider has provided a system for recording the electronic votes of the shareholders on all the items of the business sought to be transacted at the EOGM. The shareholders who were present on 21<sup>st</sup> day of March, 2016 at the venue of the meeting and had not opted to vote through the remote e-voting were provided with the facility to exercise their vote through Ballot Papers.

I hereby submit my Report as under:

- The period for remote e-voting had commenced at 9.00 a.m. on Friday, 18<sup>th</sup> day of March, 2016 and closed at 5.00 p.m. on Sunday, 20<sup>th</sup> day of March, 2016. At the end of the remote e-voting period, the facility was blocked by the Service Provider.
- At the venue of the EOGM, the empty Ballot Box kept for voting through Ballot Process was locked in my presence and members who were present at the meeting. The locked Ballot Box upon completion of the voting was unlocked in my presence. After the conclusion of the counting of votes through Ballot Papers, the votes cast through remote evoting were unblocked in presence of 2 witnesses Ms. Neha Chaurasia and Mr. Prateek Kohli who are not in the employment of the Company. The results of remote e-voting are based on the reports generated from Service Provider website <a href="https://www.evoting.cdsl.com">https://www.evoting.cdsl.com</a>.
- We have collated the votes downloaded from the remote e-voting, and ballot papers to declare the final results for each of the resolution forming part of the EOGM Notice and to ascertain the number of shares voted in "Favour" or "Against". The members who have abstained from the voting during the aforesaid voting process have not been considered in preparation of the Consolidated Report. The Ballot Papers which were incomplete and/or which were otherwise found defective have been treated as invalid and kept separately.

I hereby submit Consolidated Scrutinizer Report as per the provisions of Section 108 and 109 of the Act and Regulation 44(1) of the Securities And Exchange Board Of India (Listing Obligations And Disclosure Requirements) Regulations, 2015 containing the results of each of the resolutions of the EOGM as detailed in Annexure A.
